

Terms and Conditions of the Belweder Villa SPA

- 1. These terms and conditions of the Belweder Villa SPA ("Terms and Conditions") are applicable to all persons wishing to use SPA services.
- 2. According to these Terms and Conditions, SPA services are understood as visits at the rooms of the Belweder Villa where SPA equipment is located, as well as use of the equipment according to its intended purpose and the rules of its use.
- 3. All persons using SPA services are obliged to observe the provisions of the Terms and Services.
- Before commencing use of SPA services, please familiarise yourself with the Terms and Conditions. Commencement of the use of
 SPA services is tantamount to familiarisation with and acceptance of the Terms and Conditions.
- Any persons who decide to use SPA services accept that the use of SPA services may pose a risk to health of the user in relation with medical contraindications.
- 6. The following persons are strictly prohibited from using SPA services:
 - sick people whose sickness may pose a risk to the health of others,
 - sick people whose health may deteriorate as a result of using the sauna or workout equipment.
- 7. Persons suffering from diabetes, heart and cardiovascular diseases, patients taking anticoagulants, sedatives or beta-blockers should seek medical advice before using SPA services.
- 8. The following persons are also prohibited from using SPA services:
 - who are not staying at the Belweder Villa,
 - who appear to be under the influence of alcohol or abusive substances,
 - with open wounds and skin inflammations or other dermatological conditions,
 - whose behaviour poses a threat to others or the staff at the Belweder Villa,
 - who do not comply with the common principles of hygiene,
 - children under 13 without adult supervision.
- 9. The SPA centre is a quiet and peaceful area.
- **10.** SPA services are available all days per week, between 5 and 9 PM. It is prohibited to use SPA services outside the opening hours, unless their use is approved by an employee of the Villa Belveder.
- 11. Please be careful at the SPA centre, in particular, do not run.
- 12. Employees of the Belweder Villa have the right to ask persons to leave if they do not respect the rules regarding keeping quiet or if they cause discomfort to other guests in another way. Individuals breaching the peace or the provisions of the Terms and Conditions will be removed from the building.
- 13. In the SPA centre, it is prohibited to:
 - smoke,
 - carry or consume alcohol,
 - carry or consume food,
 - carry glass containers,
 - use open fire,
 - chew gum.
- 14. Persons using the SPA centre may change in the changing room and leave their belongings in the designated lockers. The staff bears no responsibility for items left in the lockers or at the SPA centre.
- 15. It is prohibited:
 - to activate or use SPA equipment without permission, unless such activation or use is required due to the character of the device or
 - the instruction manual for the device;
 - to connect SPA equipment to power supply without permission;
 - to attempt to repair SPA equipment at one's discretion,
 - to carry and connect one's own electrical equipment to power supply at the SPA centre, for instance hairdryers, straighteners, razors, etc.
- 16. Please inform a member of staff at the Belweder VIIa about any defects or problems.
- 17. Please change your shoes when entering the SPA centre.
- **18.** It is prohibited for children to use the sauna.
