

TERMS AND CONDITIONS OF USING THE SWIMMING POOL AND SAUNAS AT THE HOTEL ANDERS

- 1. It is considered that any person who has entered the swimming pool area has become familiar with the terms of the present Rules and Regulations and has undertaken to follow them.
- 2. The swimming pool area is open every day from 8:00 a.m. to 9:00 p.m..
- 3. The saunas are open from 9 a.m. to 9 p.m..
- 4. Entry to the swimming pool and sauna area is granted to hotel guests and guests who are not staying at the Anders Hotel but who identify themselves at the reception with a Club Card issued by the Anders Hotel or have an entry pass.
- 5. The use of the swimming pool is only possible:
 - in a costume designed for swimming,
 - after changing shoes in the changing room into swimming pool shoes (barefoot is allowed),
 - after compulsory washing of the whole body with soap and rinsing in the shower,
 - after passing through the paddling pool located at the entrance to the swimming pool.
- 6. People spending time in the swimming pool and sauna area are forbidden to:
 - cause situations that might endanger the safety of others,
 - run around the area,
 - jump into the water outside the designated areas,
 - make noise,
 - use the swimming pool in anything other than swimwear (men's shorts and women's swimwear),
 - swim in the pool wearing goggles other than swimming goggles,
 - use in the swimming pool area clothing and objects that are visibly soiled or which may react chemically with the water,
 - use of footwear on the area that leaves dirty footprints on the floors,
 - smoke,
 - bring in and consume any alcoholic beverages,
 - bring in objects that could cause damage to others in the premises,
 - bring in animals.
 - enter areas that are not accessible to the public.
- 7. People whose condition indicates consumption of alcohol or other similarly acting substances will not be allowed in the swimming pool and sauna area.
- 8. People suffering from infectious diseases, with externally visible dermatological diseases and with dressings on their bodies are not allowed to use the services of the pool and saunas.
- 9. Anyone who damages the equipment or facilities of the pool and saunas, or who contaminates the pool, bears full material responsibility for the damage caused. For children, the material liability is borne by their parents or caretakers.



- 10. Any situation requiring the intervention of authorized staff of the facility or external services should be immediately reported to the pool staff at 640.
- 11. The Hotel Anders is not responsible for valuables left in the lockers, in particular: watches, money, credit cards, all kinds of documents and keys, mobile phones and other valuables.
- 12. Before leaving the changing rooms for the area of the sports and recreations, please check whether the locker has been closed. The Hotel Anders is not responsible for items left in open or improperly closed lockers or on the outside of lockers.
- 13. Before leaving the changing room, the locker must be emptied and left open.
- 14. It is prohibited to bring items other than those for personal use and swimming into the swimming pool and sauna areas of the sports and recreation section.
- 15. While staying in the swimming pool and sauna area at The Hotel Anders the swimming pool staff may, for safety reasons, restrict access to certain people.
- 16. Guests using the sports and recreation area are obliged to follow the directions of the facility staff, as well as to maintain cleanliness and silence.
- 17. Children under 7 years of age may stay and use the sports and recreation area only when accompanied by adults who have purchased their stay and know how to swim (Journal of Laws No. 57 of 7 June 1997).
- 18. Children under 3 years of age may stay in water only in special leak-proof nappies.
- 19. Disabled people whose medical conditions prevent them from controlling their physiological activities are not allowed to use the swimming pool and sauna services.
- 20. The staff of the swimming pool and saunas of the Anders Hotel have the right to strictly enforce compliance with the Regulations, including removal from the sports and recreation area.
- 21. Smoking is strictly prohibited in the swimming pool and sauna area.
- 22. People who violate public order or the provisions of the regulations will be removed from the swimming pool and sauna area (Journal of Laws No. 57 of 06.1997 § 15, item 3c), regardless of possible referral to the misdemeanour procedure.

The Hotel Anders Management, which owns the swimming pool and saunas, is not responsible for accidents resulting from not complying with the regulations.
