

## Terms and conditions of CAMPER PARK, STARE JABŁONKI



- The owner and manager of Camper Park is PHU Martom-Traveland Sp. z o.o. Hotel Anders in Stare Jabłonki (further referred to as Hotel Anders or Hotel).
- **The check-in/out time is from 16:00 to 12:00 the following day.**
- The booking of space for the park's campervan is made by calling or by emailing the hotel reception.
- **The booking is guaranteed by paying for the first night of your stay in advance.**
- **In case of absence of a guest during the first day, the booking is cancelled and the deposit paid is lost.**
- **The quiet hours are from 22:00 to 06:00.**
- **Guests registered at Camper Park can use the infrastructure of the Anders Hotel as available**, i.e.: swimming pool, saunas and a gym, while dining outlets, restaurants, other attractions - according to the price list of the Hotel **It is possible to participate in the programme of attractions and animations of the hotel if such is prepared by the Anders Hotel for its Guests**, i.e.: concerts with music, animations for children, etc.
- Those arriving at the Camper Park are required to complete the registration formalities at the hotel reception and to pay in advance (at check-in) for the declared duration of stay. The proof of payment must be kept until the day of check-out. The offer is non-refundable - in case of shortening the stay, the amount paid is lost.
- When registering at the Anders Hotel Reception, each camper will receive a special tag which must be placed in a visible place behind the windscreen of the car/camper during the stay.
- In the case of extending the stay, the Guest is obliged to pay the fee until 12:00 p.m. of the day on which the last paid camping day ends and extending the stay on a camping parcel is possible only after establishing the availability of a place on subsequent days at the reception..
- People who are not registered at the Camper Park may stay there until 22:00. For the safety of the guests staying at Camper Park, the entrance gate is closed between 10 p.m. and 7 a.m. During this time, only vehicles of registered persons may enter and leave the car park. During the above mentioned hours (22.00-07.00) car traffic is stopped on the camping area.
- **It is forbidden to barbecue on the beach area of the hotel**, outside the parking area of the camper, caravan.
- **Pets are allowed at the Camper Park**; the caretaker must have a current vaccination certificate and, in the case of dogs, a muzzle and a leash. Dogs are not allowed on the beach area of the hotel. Detailed rules and regulations for the stay of pets on the hotel premises are available at the reception and at [www.hotelanders.pl](http://www.hotelanders.pl). Dog owners are obliged to clean up after their animals.
- Segregation of rubbish is obligatory in the area of Camper Park.
- The visitor to the Camper Park is financially responsible for any damage or destruction of the equipment and technical devices of the Park caused by the visitor or by his/her guests. Camper Park may refuse to accommodate a guest who, during the previous stay, grossly violated the Camper Park regulations or otherwise disturbed the guests' stay or the functioning of Camper Park. The staff (service) of Camper Park/Hotel may eject from the premises of Camper Park a person whose behaviour disturbs the peace or endangers the safety of other persons staying in Camper Park.
- **It is forbidden to:**
  - wash dishes and emptying camping toilets in places not designated for this purpose,
  - bath animals in sanitary facilities,
  - wash vehicles and caravans in the Campsite Park,
- Camper Park / Hotel Anders is not responsible for any items left without proper care.
- Entering the Camper Park area means acceptance of these Regulations.
