

## **REGULATIONS FOR STAYING WITH PETS AT HOTEL ANDERS – “YOUR PET SPEAKS”**

### **CONDITIONS OF ADMISSION**

1. To be welcomed at Hotel Anders, my owner must report my stay at the time of booking and provide my breed. This is very important, as the number of rooms available for pets is limited.
2. For the safety of all people and animals in the hotel, I may only be a domestic pet. The Hotel reserves the right to refuse animals commonly considered dangerous or aggressive, including reptiles, arachnids, and the following dog breeds: American Pit Bull Terrier, Perro de Presa Mallorquin, American Bulldog, Dogo Argentino, Perro de Presa Canario, Tosa, Rottweiler, Akbash Dog, Anatolian Karabash, Moscow Watchdog, Caucasian Shepherd Dog (in accordance with the Regulation of the Ministry of Interior and Administration of 28 April 2003).
3. If my owner does not report my stay in advance, the Hotel may refuse to accommodate me and retain the deposit.
4. To stay at the Hotel, I must have a health booklet with up-to-date vaccinations, especially against rabies, as well as proof of deworming.
5. To ensure everyone's safety, whenever I am outside the room, I must wear a leash, collar, muzzle, or be in a crate—depending on my species. Dogs must always be walked on a leash.
6. Due to safety and allergy concerns, I am not allowed in restaurants, bars, recreational facilities, the club, or indoor and outdoor children's playgrounds.

### **NOISE & DISTURBANCES**

1. I must not disturb other Guests. I need to make sure I don't make noise, especially during quiet hours.
2. If repeated complaints occur, the Hotel has the right to terminate my stay.
3. If Hotel staff have reasonable grounds to believe that I am disturbing other Guests, damaging property, or posing a threat, management will contact my owner. If contact is not possible, the Hotel may enter the room with staff and, if necessary, with the assistance of appropriate services, remove me from the Hotel. All costs will be covered by my owner.

### **HYGIENE & CLEANLINESS**

1. My owner is responsible for cleaning up after me in the room, in shared areas, and outside the Hotel. Waste bags are available at the Reception.
2. I am not allowed on beds or sofas.
3. If I am a cat, my owner must provide a litter box with sand and empty it into a plastic bag, which must then be disposed of in the container indicated by Hotel staff.
4. If I stay alone in the room, my owner must hang the door tag on the outside of the door. Tags are available in the room or at the Reception.
5. For safety reasons, room cleaning is performed only when my owner is present or when I am not in the room. To arrange a suitable time, my owner should contact the Reception or Housekeeping.

## **RESPONSIBILITY**

1. My owner is responsible for any damage or contamination caused by me and must cover all costs.
2. Any damage to Hotel property or to other Guests' property will be assessed by management, and all costs will be charged to my owner.
3. I must remain under my owner's supervision throughout the entire stay.
4. Dogs must be walked on a leash and, if required by law, with a muzzle, under the care of the owner or an authorized person.

## **GENERAL PROVISIONS**

1. The fee for my stay is 70 PLN per night.
2. My owner declares that they have read and accepted all provisions of this regulation.
