### Regulations for staying with animals

#### **Admission conditions**

- 1. Notification of arrival: The arrival of a guest with an animal must be reported in at the time of booking. The hotel may not accept guests without prior notice reporting the presence of an animal.
- 2. Pets: Only domestic animals are allowed at the Hotel. The hotel has the right to refuse to accept animals considered dangerous or aggressive, including reptiles, arachnids and dogs of the breeds listed in Regulation of the Minister of Internal Affairs and Administration of 28 April 2003.
- 3. Health documentation: Animals must have a health booklet with current vaccinations and deworming certificate. Sick animals or during convalescence will not be accepted.
- 4. Safety: The animal must have a leash, collar, muzzle or cage, etc. depending on the species. Animals aggressive towards other animals and people will not be accepted.
- 5. Fee: The fee for an animal's stay is PLN 120 per day.

### Noise and interference

- 1. Quiet hours: The animal cannot disturb other guests, especially during the night.
- 2. Complaints: In case of repeated complaints from other guests, the Hotel reserves the right to remove the animal at the expense of its owner.
- 3. Disturbances: If the hotel employees find that the animal is disturbing the stay of others guests or damages Hotel property, they will attempt to contact the owner. In case lack of contact, the Hotel may enter the room with the help of appropriate services and remove the animal. The costs of these activities are covered by the animal owner.

## **Hygiene and cleanliness**

- 1. Responsibility for cleanliness: The owner is responsible for maintenance cleanliness after your pet, both in the room, common areas and on the premises area surrounding the hotel. Please clean up after your pet.
- 2. Prohibition on furniture: Pets are not allowed on beds and sofas.
- 3. Cleaning: Only cleaning of the room where the animal stays takes place

during the owner's presence or in his absence, after arrangement with the reception.

# Responsibility

- 1. Damage and pollution: The owner of the animal is responsible for any damage or contamination caused by his animal. Costs these damages will be assessed by the Hotel Management and charged to the owner.
- 2. Supervision: The animal must remain under supervision at all times while on the premises hotel. Dogs must be walked on a leash and with a muzzle and supervised owner or authorized person.

## Prohibited areas

1. No-access zones: Pets are not allowed in the swimming pool, in the restaurant, playroom and on the playground. There are facilities for owners and their pets specially designated tables on the restaurant terrace. You can also use Room Service.

#### **Additional information**

- 1. Consent of the Management: The stay of animals on the hotel premises requires the approval of the Management hotel when making your reservation.
- 2. Cleaning up after the animal: Owners are obliged to clean up excrement left behind by your pet. Bags are available at the reception excrement.
- 3. Consent to the regulations: The owner declares that he has read the regulations of animals stay at the Hotel and accepts its provisions.
