



TERMS AND CONDITIONS OF STAY AT THE SEASIDE PARK HOTEL

1. Seaside Park Hotel welcomes pets.
2. Please report the arrival with your pet when booking your stay.
3. The pet fee is 100 PLN/day according to the current price list.
4. The pet stay at the hotel requires the approval of the hotel management, which takes place at the stage of booking a stay.
5. When making a reservation, please specify the species / breed of animal. The Hotel reserves the right to refuse to accept animals whose species / breed is widely regarded as dangerous or aggressive.
6. The hotel will only accept healthy animals with a health book (current rabies vaccination and deworming is absolutely required).
7. The Hotel has the right to refuse to accept animals that are ill or in the process of convalescence.
8. The owner of the animal declares that the animal(s) are healthy and pose no threat to other people and animals.
9. Animals should stay in the rooms. Outside the rooms animals must be walked on a leash and be under the care of the owner. In special cases, the hotel reserves the right to order the muzzle.
10. owners are required to have their own dog food.
11. The use of towels and bed linen for animals, animals staying on the bed or sofa and physiological needs in the room are not allowed.
12. If the bedding, mattress, carpet or other items of equipment in the room, where the animal is staying, will be soiled by the animal (hair, mud) or damaged, the owner is obliged to cover the cost of damage at a price determined by the Hotel Management.
13. The owner of the animal is financially responsible for any damage to hotel property and private property of other guests due to the fault of the animal.
14. In case of leaving the animal alone in the room, please leave the tag on the door handle, on the outside of the door. Tags are available at the hotel reception.
15. for safety reasons, cleaning of rooms where there are animals, takes place only in the presence of the owner or during the absence of the animal in the room. In order to arrange a convenient time, please contact the staff.



16. In the event that an animal left in the room interferes with the stay of other guests, destroys hotel property, or may cause a threat to themselves or other guests, the Hotel Management will immediately contact the owner in order to resolve the problem. If contact is not possible, the hotel reserves the right to enter the guest's room with the help of appropriate services and take the animal to the nearest animal shelter. All costs resulting from the above actions are covered by the owner of the animal.

17. The owners of the animal are responsible for compliance with hotel regulations on maintaining the peace at night in the hotel and not disturbing other guests.

18. It is prohibited to bring animals to the catering and recreation facilities and the children's playroom.

19. Atrium Bar has prepared specially designated tables for owners and their pets. Room service is also available.

20. The owner is required to always clean up the excrement left by their pet.

21. The owner declares that he/she is familiar with the regulations of the stay of animals in Seaside Park Hotel and accepts its provisions.
