Terms and Conditions for Events at Buczyński Hotels Hotel Buczyński **** Medical&SPA and Park Hotel **** KUR&SPA Buczyński

§ 1. General Provisions

1. These terms and conditions apply to all events organised at Buczyński Hotels: Hotel Buczyński **** Medical&SPA and Park Hotel **** KUR&SPA.
2. The organiser of the events is W. Buczyński Sp. z o.o.
3. Participation in the event implies acceptance of these regulations.

§ 2. Admission and safety

1. Admission to events is only permitted upon presentation of a ticket, invitation or other form of registration.
2. Participants are required to comply with safety rules, staff instructions and the hotel's terms and conditions.
3. The organiser reserves the right to refuse entry to any person:
 - under the influence of alcohol or intoxicating substances,
 - behaving aggressively,
 - disrupting the course of the event.

§3. Conduct of participants

1. It is prohibited to bring dangerous items, alcohol, drugs or other materials prohibited by law.
2. Participants should behave in a manner that does not disrupt the event or the comfort of others.
3. Any breach of these regulations may result in the participant being removed from the event without the right to a refund.

§4. Photography and filming

1. Participants:
 - a. May take photographs and make video recordings for private use, provided this does not disturb other participants or disrupt the course of the event.
 - b. Photography and filming are prohibited in restricted areas (media, VIP).
 - c. The use of flash photography or equipment that hinders participation in the event is prohibited.
2. Organiser:
 - a. May take photographs and make video recordings featuring participants for the hotel's promotional purposes (website, social media, press materials).
 - b. By attending the event, participants consent to such photographs and recordings being taken.
 - c. Anyone who does not consent to the publication of their image is asked to inform the staff.

§ 5. Liability

1. The organiser is not liable for personal belongings left unattended during the event.
2. Participants are liable for any damage caused in the hotel or during the event.
3. The organiser shall not be liable for the cancellation or alteration of the event due to circumstances beyond its control, including force majeure.
