

## REGULATIONS OF THE RIVERLANDIA PLAYROOM AT RIVER STYLE HOTEL & SPA

§ 1

- 1. The Playroom is intended for children 0-12 years old.
- 2. Admission to the playroom for hotel guests is free. Admission for external guests is charged. A detailed price list is available at the hotel reception.
- 3. Minors may stay in the Playroom area only under the supervision of adults. The management and staff of the Playroom do not provide child care. Persons under the care of children are obliged to take care of them throughout their stay in the Playroom and are responsible for their safety and any damage caused by them..
- 4. If you purchase a birthday package or during organized workshops, children may stay in the Playroom under the supervision of the Staff, after prior arrangement with the Playroom Staff...
- 5. Shoes and outerwear remain in the locker room, children enter the Playroom wearing socks or sports shoes..
- 6. Guardians enter the room without shoes or wearing protectors, this is dictated by the cleanliness of the Playroom.
- 7. In the Playroom area the following applies:
- ban on bringing in dangerous, sharp and glass objects;
- ban on bringing in food and drinks;
- prohibition on consuming alcohol, intoxicants and staying with people after consuming such substances, and smoking;
- no animals allowed; chewing gum is prohibited
- 8. Any aggressive behavior is prohibited in the Playroom, e.g. fighting, pushing, going up slides, two or more people going down a slide together at the same time, climbing on the outside of the playground structure.
- 9. When entering the Playroom, children should remove any items that may pose a threat, in particular: watches, jewelry, chains, rings, bracelets, earrings, belts with sharp buckles, clothes with long strings (e.g. on hoods) or strings only, pens, mobile phones, electronic players etc.
- 10. Guests should use equipment, games and attractions in accordance with their intended use and instructions.
- 11. Guests are obliged to comply with the provisions of the Regulations and Instructions and follow the recommendations of the Staff.

- 12. The manager is not responsible for accidents caused by non-compliance with the Regulations, instructions or recommendations of the Staff, as well as in situations where an accident is caused by a person who is under the influence of alcohol or is under the influence of drugs..
- 13. Guests are responsible for damage caused as a result of failure to comply with the Regulations, Instructions or instructions of the Staff, as well as caused by other culpable action or omission.
- 14. In the event of any random events, accidents, noticed defects or other events and behaviors that pose a threat in the Playroom, please inform the Staff.
- 15. The Manager may, at its own discretion, request that Guests leave the Playroom, in particular by persons violating the Regulations, instructions and generally accepted norms.
