

## Information concerning the usage of Video Monitoring



Pursuant to Art. 13 section 1 and 2 of Regulation of the European Parialiament and of the Council (UE) 2016/679 of April 27, 2016 on the protection of natural persons with regard to processing personal data and on the free movement of such data and repealing the Directive 95/46/WE (hereinafter reffered to as "GDPR"), we inform you that:

- 1. The administration of personal data recorded and obtained from the video-surveillance system is the company FENIKS Sp. z o.o. based in Gdańsk at st. Waryńskiego 46a/1 in River Style Hotel & SPA based in Reda at st. Pucka 10B represented by the President of the Company's Management.
- 2. Accordingly to GDPR, the President of the Company's Management informs that River Style Hotel& SPA is introduced to proper technical and organizational services in terms of safety of personal data, which protect from accidental or illegal damage, lost, modification, or any unauthorized access to personal data processed by Hotel, and also from any other unlawful form of processing data.
- 3. Technical and organizational measures protecting personal data processed by River Style Hotel & SPA in Reda have been prepared according to Art. 32 and 35 GDPR.

- 5. The legal basis for the processing of personal data in the monitoring system is Art. 6 section 1 letter e and f GDPR in relation to Art. 222KP, where the legitimate interest is the safety of persons and property, of people staying in the area administered by River Style Hotel & SPA in Reda, as well as its rooms, ensuring the legitimate interests of the data controller.
- 6. Monitoring includes: entries to the building, corridors, indoor and outdoor areas, and also parking lot of River Style Hotel & SPA in Reda at st. Pucka 10B.
- 7. Personal data in the form of an image are registered by cameras recording images continuously in day/night mode. <u>Cameras do not record sound</u>.
- 8. Personal data in the form of an image will be shared only to entities authorized to receive them pursuant to the provisions of applicable law.
- 9. Personal data in the form of an image will not be transferred to a third country or international organization.
- 10. Personal data in the form of an image are stored by the Data Administrator for a maximum period up to 14 days.
- 11. In the case when image recordings constitute evidence in proceedings conducted on the basis of legal provisions or if River Style Hotel & SPA in Reda as an employer in relation to employees became aware that they may constitute evidence in the proceedings, the deadline specified in point 10 shall be extended until the final conclusion of these proceedings.
- 12. Access to data in the monitoring system is strictly protected and available only to specific users, authorized by the Data Administrator.
- 13. A person registered by the monitoring system has the right to access and request personal data restrictions on its processing.
- 14. A person registered by the monitoring system has the right to lodge a complaint with the supervisory authority if it finds that it has reliable evidence that the data is processed in violation to applicable law.
- 15. Monitoring data will not be used to make automated decisions, they will not be used for profiling purposes.
- 16. Providing personal data in the form of an image is necessary for technical reasons to stay in the outdoor and indoor area of the River Style Hotel & SPA in Reda at st. Pucka 10B.
