

Information for individuals who have consented to the processing of personal data by Hotel Swing Sp. z o.o. based in Krakow.

In connection with your voluntary consent to the processing of personal data by **Hotel Swing Sp. z o.o. based in Kraków** before October 1, 2024, we inform you that on September 30, 2024, the following merger took place

the company:

Park Wodny w Krakowie Spółka akcyjna based in Kraków (hereinafter referred to as the "Acquiring Company")

with the company:

Hotel Swing Spółka z ograniczoną odpowiedzialnością based in Kraków (hereinafter referred to as the "Acquired Company").

The perger occurred under Article art. 492 § 1 point 1 of the Commercial Companies Code, i.e., through the transfer of all assets of the Acquired Company to the Acquiring Company.

As a result of the merger, the Acquired Company, Hotel Swing Sp. z o.o. based in Kraków, ceased to exist as a legal entity.

As of October 1, 2024, the Acquiring Company, Park Wodny S.A. based in Kraków, legally becomes the new Data Controller, entitled to proces personal data based on consents given to Hotel Swing Sp. z o.o. before September 30, 2024.

All rights and obligations of the Acquired Company have also beed transferred to the Acquiring Company, and the empolyees of the Acquired Company have become employees of the Acquiring Company by operation of law.

In light of these changes, you have the following options:

A) Accept the consequences of the merger, which means that the current Data Controller for the consents you have given Park Wodny w Krakowie S.A. based in Kraków. The company will proces the data under these consents in accordance with the purposes for which they were given, based on the legitimate interest under Article 6(1)(f) of GDPR.

B) Withdraw consent or object to the processing of data under the consents previously given (before September 30, 2024) to the new Data Controller: Park Wodny w Krakowie S.A. based in Kraków (via e-mail: biuro@parkwodny.pl)

If you do not withdraw your consent or object to the processing of personal data, the Data Controller will continue to proces the data under Article 6(1)(a) and Article 6(1)(f) of GDPR.

GDPR Information Clause:

- 1) The Data Controller (ADO) is Park Wodny w Krakowie S.A. (hereinafter referred to as "ADO"), and can be contacted via email at biuro@parkwodny.pl, by phone at +48 12 61 63 190, or by post at the company's address: ul. Dobrego Pasterza 126, 31-416 Krakow.
- 2) ADO has appointed a Data Protection Officer (DPO), who can be contacted via email at inspektor@parkwodny.pl or inspektor@hotelswing.pl to obtain necessary information regarding the processing and protection of your personal data.
- 3) Personal data will be processed by ADO based on your consent and legitimate interest, solely for the purpose for which it was given, and will be processed until consent is withdrawn or an objection is submitted.
- 4) Withdrawal of consent or submission of an objection can be made by sending an email to marketing@hotelswing.pl, the addresses mentioned in points 1 or 2, or by post to the address in point 1. Withdrawal of consent or objection will result in the immediate cessation of data processing (regarding your email address or phone number). Withdrawal of consent or objection does not affect the lawfulness of data processing that took place before the withdrawal/objection.
- 5) Personal data may be shared by ADO with entities authorized by law or with entities providing services to ADO, such as auditing or legal advisory services, while ensuring appropriate data protection.
- 6) You have the right to access your personal data, the right to correct it, the right to request its deletion or restriction of processing at any time, the right to data portability, the right to object to data processing, and the right to withdraw consent at any time.
- 7) You have the right to lodge a complaint with the President of the Personal Data Protection Office.
- 8) Your personal data may be transferred by ADO to recipients located outside the European Economic Area (EU countries, as well as Iceland, Norway, and Liechtenstein) only in compliance with GDPR, i.e., based on an adequacy decision, binding corporate rules, or standard contractual clauses adopted by the European Commission, depending on the case.
- 9) ADO ensures the protection of personal data in accordance with applicable laws, especially GDPR requirements.
