These entities have entered into a joint agreement on the operation and maintenance of the "Park Station" and agreed on a strict division of roles and responsibilities, purposes and methods of processing personal data of customers in this zone as part of the services provided there.

According to the assumptions of this agreement, it is agreed that:

- Clients purchasing services in Park Wodny w Krakowie S.A. regarding the "Park Station" zone are
  in this respect customers of this entity and as for these services, all settlements, applications,
  inquiries, complaints will be considered through this entity,
- Customers purchasing services at Hotel Swing Sp. z o.o., which include access to the "Park Station" zone, are customers of this entity and as for these services, all settlements, applications, inquiries, complaints will be considered through this entity,

# with the proviso that:

Customers purchasing gastronomic services at the "Park Station", and these services are sold
exclusively by Hotel Swing Sp. z o. o are clients of this entity and as for these services, all
settlements, applications, inquiries, complaints may be considered through this entity or through
Park Wodny w Krakowie S.A.

Therefore, in the case of using the entrance to the Park Stable as part of the services purchased at Hotel Swing Sp. z o.o. based in Krakow:

1. The administrator of personal data is Hotel Swing Sp. z o.o. (hereinafter referred to as ADO), address: ul. ## 2. Legal grounds and purposes of personal data processing.

ADO may process your personal data to the extent necessary pursuant to:

- Art. 6 sec. 1 lit. b) GDPR, in order to fulfill the obligations and rights resulting from your striving to conclude a contract or its implementation, and regarding the provision of services in the Park Station zone:
- Art. 6 sec. 1 lit. c) GDPR, in order to fulfill the legal obligation incumbent on PDC, including: meeting the requirements of the Accounting Act, the tax ordinance,
- Art. 6 paragraph 1 lit. f) GDPR, in order to implement the legitimate interests of PDC, including possible determination, investigation or defense of claims.

Providing personal data is voluntary, but their absence will prevent you from using the services in the Park Station zone.

### 3. Information on the co-administration of personal data in the Park Station zone

The area of the "Park Station" zone is subject to visual monitoring.

The joint controllers of Personal Data in this regard (hereinafter referred to as: WDO) are:

Video surveillance was used to ensure the safety of people and property, pursuant to Art. 6 section 1 letter f) of the GDPR (i.e. in the legitimate interest of the WDO).

The monitoring image is recorded by the WDO as part of an agreement and a strictly defined division of roles and responsibilities between the two above-mentioned. entities and is deleted by overwriting after 7 days.

- only to the extent necessary and only on the basis of appropriate authorizations or assignments,
  - entities authorized under the provisions of law.

#### 5. Transfer of personal data to a third country or an international organization

As part of the provision of services in the Park Station zone, ADO does not transfer personal data to recipients located outside the European Economic Area (European Union countries and Iceland, Norway and Liechtenstein), subject to the cases of purchase of services by intermediaries (when the services are part of a wider hotel offer). Then you are encouraged to read the brokers' regulations, which are always available to you before choosing a specific channel for the purchase of the offer.

### 6. The period for which personal data will be stored:

ADO will process personal data in the time necessary for the implementation and settlement of services and will store them for the period required by law for the purposes of archiving, meeting the requirements of the Accounting Act and keeping tax documentation, as well as for the possible needs of settling mutual claims.

Data processed as part of video monitoring are automatically overwritten by the WDO and will be stored for up to 7 days, after which they will be replaced with current data, subject to situations requiring investigation, due to incidents of violation of the safety of persons and property. For such exceptional situations, the processing of data from monitoring will take place adequately to the circumstances and legal requirements.

### 7. Your rights:

You have the right to access your data and the right to rectify incorrect data, supplement incomplete data, delete data - after the expiry of the storage period required by law, processing restrictions and the right to transfer the data provided.

In the case of personal data processed on the basis of:

• Art. 6 section 1 letter f) of the GDPR - due to a legitimate interest ADO /WOD

you have the right to object to the processing of your personal data.

You also have the right to lodge a complaint with the supervisory body (the President of the Office for Personal Data Protection).

### 8. Information on automated decision making:

You are not subject to decisions made in an automated manner (without human intervention), as well as profiling in this area.
