



VEHICLE ACCESS, PARKING SPACE, INTERNAL ROADS WITHIN THE RESORT

THESE RULES AND REGULATIONS GOVERN THE ENTRY AND USE OF THE CAR PARK AND INTERNAL ROADS WITHIN THE KRUPÓWKA MOUNTAIN RESORT AND THE RESORT CAR PARK IN POZIOMKOWA STREET BY THE GUESTS.

PERMISSION FOR ENTRY

Only Guests having a valid booking at the Krupówka Mountain Resort are entitled to enter the facility premises.

A Guest driving a vehicle entering the car park belonging to the Resort enters thereby into a short-term contract of a parking space rental on the terms and conditions set out in these Regulations (Article 69 of the Civil Code and Article 384 § 2 of the Civil Code).

Only the Guest who concluded a parking space rental contract by providing their car's registration numbers, also to be entered into the barrier / gate operating system when making a booking or checking in to the Resort, is entitled to use the Car Park.

LIABILITY OF THE FACILITY

The Resort provides access to the premises and parking spaces only for the Guests of the Resort having a valid booking at the Resort. By leaving their vehicle in the Car Park, the Guest does not enter into a contract for the safekeeping of the vehicle or property, which would oblige the Resort to be liable for damage caused by theft, destruction or damage to the vehicle or property occurring in the Car Park as well as to be liable for the items in the vehicle or forming parts of its equipment.

The facility's car park is neither attended nor subject to video surveillance.

The Resort bears no liability for the vehicles or property left in the Car Park.

The rental contract is concluded upon entry to the Car Park and ends upon exit from the Car Park. The Car Park is open daily during the hours limited by the time of entry or exit and specified in the booking conditions. The Resort closes the entrance to its premises as well as the exit therefrom for the night at the times stated in the booking conditions. The Guest is charged the parking fee for each started day of using the Car Park, depending on the number of the hotel days purchased. The current parking fee list is available at the Reception and in the booking content.

Parking fees are paid at the Reception. The maximum parking period is consistent with the booking and is up to 10 days. If the Guest wishes to have a VAT invoice issued, they need to report it at the Reception and pay the parking fee.

Every person, not only the Guest of the Resort, by entering the Car Park with or without an authorised vehicle, agrees to the terms and conditions of these Rules and Regulations and undertakes to comply with their provisions. The parking fee is charged in accordance with the

current price list for the Resort Guests available at the Reception. Information for the Guest can also be found on the website when the booking is purchased. The parking fee and the penalty for unauthorised entry by outsiders are two completely different charges.

LIABILITY OF THE DRIVER

Entering too early, stopping or reversing a vehicle when entering or exiting through the gate or barrier may result in damaging the vehicle or parking facilities, for which the driver of the vehicle shall be liable. The Resort shall recognise any person driving a vehicle and causing damage as having authority to drive the vehicle and shall enforce the cost of the damage against that person.

On the Car Park premises, the provisions of the Traffic Law Act of 20 June 1997 (i.e. Journal of Laws of 2012, item 1137, as amended) apply. The Car Park User is obliged to comply with these Rules and Regulations and the instructions given by the parking space information staff.

PARKING SPACE

The Guest is obliged to park their vehicle only in designated parking spaces, in a way that does not hinder the manoeuvres of other authorised users of the Car Park, and not to park their vehicle in the parking spaces of other users of the Car Park and not in traffic routes or unauthorised areas.

If the Guest parks OUTSIDE in the spaces designated for the purpose or if persons unauthorised thereto enter the Car Park, the facility staff has the right to demand that the vehicle is immediately removed from the Car Park area or moved to a proper parking space. Persons not authorised to enter who violate the right of entry will be charged an entry penalty. The penalty is payable at the reception in the amount specified in the price list. Once the payment due has been made, the exit is opened. Moreover, if the driver, by parking their vehicle improperly, obstructs or blocks traffic in the Car Park or on the internal roads of the Resort, the Resort staff will be entitled to call the relevant entities to tow away such a vehicle and will do so at that person's expense.

MATERIAL LIABILITY

The Guest is liable for all damage caused to the Krupówka Mountain Resort and its car park areas or to third parties using the Car Park by themselves, the Resort's employees, contractors or persons accompanying the Guest. The Guest shall be fully liable for contaminating the Car Park.

The Guest using the Car Park is liable for any damage caused by giving the Car Park ticket/card to a third party or losing it. In the event of any incident occurring on the premises of the Car Park that would give rise to any liability on the part of the Guest referred to above, the Guest will be obliged to – before leaving the Car Park – immediately inform a receptionist about it and make a written declaration to that effect as well as to pay all the costs on the spot. On the premises of the Car Park and on the internal roads, the speed limit and cautious driving are obligatory. The Guests using the Car Park and the internal roads thereof are required to drive with their lights on as for road driving.

PROHIBITED BEHAVIOUR

On the premises of the Car Park and Internal Roads of the Krupówka Mountain Resort, it is forbidden to: store fuels, flammable substances, leave empty fuel containers, refuel vehicles, use open fire and smoke, leave a vehicle with a running engine, park vehicle with a leaking fuel system or other leaking systems. Persons who are not authorised to enter and persons who are not guests with a valid booking may not stay within the car park and internal roads.

Vehicles with hazardous or flammable materials are prohibited from entering the Car Park. Repairing, washing, vacuuming vehicles, changing coolants, fuel or oil, as well as polluting the Car Park in any other way, is forbidden in the parking spaces, internal roads and roads leading to and from the Car Park.

It is forbidden to park a vehicle that is not technically sound and that may cause danger to other Users of the Car Park as well as cause soiling, e.g. due to leakage of oil or operating fluids, in the parking spaces, internal roads as well as entrance and exit roads.

Soiling with oil spills or operating fluids and contaminating the premises will be charged according to the price list available at the reception.

The Resort reserves the right to change the Rules and Regulations and the price list at any time by announcing the changes on the website.

These Regulations entered into force on 23/07/2024.
