

UNGUARDED PARKING REGULATIONS

1. These regulations define the terms and conditions of the parking lot, the area of which is an integral part of the INTERFERIE AQUAPARK SPORT HOTEL at Kościuszki 1 Street in Świeradów-Zdrój, belonging to INTERFERIE Spółka Akcyjna, entered in the register of entrepreneurs of the National Court Register under the number 0000225570, address for delivery: INTERFERIE S.A., ul Rycerska 24, 59-220 Legnica (hereinafter INTERFERIE).

2. Parking lot is intended for parking vehicles, trailers and semi-trailers with a maximum permissible weight not exceeding 3.5 tons and in designated bus places. Vehicles carrying flammable, corrosive, explosive materials and other similar materials and substances that may pose a risk to people and property are strictly prohibited.

3. By the vehicle operator shall be understood as the owner of the vehicle or another person using the vehicle.

4. Each operator of the vehicle by entering the parking area agrees to the terms of this regulations and terms and undertakes to strict compliance with its provisions.

5. INTERFERIE assumes no liability for:

- damage caused by loss, theft, destruction or damage to the operator's vehicle caused in the parking lot by the operator of the vehicle, third party or force majeure,
- things left in the parking lot, both inside and outside the operator's vehicle or as a operator's vehicle equipment,
- traffic or parking damage to vehicles and people using the parking lot.

6. By leaving the vehicle in the car park, the operator does not conclude with INTERFERIE a vehicle storage agreement or any other agreement that would oblige INTERFERIE to take care of the operator's vehicle. The operator leaving it in the parking lot only rents the parking space of his choice. Elements fences parking, in particular, detentions and barriers are intended solely to prevent the use of the parking lot without paying an appropriate fee.

7. Parking is a UNGUARDED PAID CAR PARK. The parking lot can be monitored using image recording devices (cameras). Recordings from the CCTV can be used to determine liability to vehicle operator who do not comply with the provisions of this terms and regulations.

8. Parking is open 24 hours a day, 7 days a week.

9. The use of the car park is initiated at the time of the first entry of the vehicle into the parking area. When entering the car park, the operator of the vehicle undertakes to immediately appear at the reception in order to confirm the possibility of using the car park and make settlements in this respect.

10. Parking is payable according to the current price list set in INTERFERIE AQUAPARK sport HOTEL in Świeradów-Zdrój, located at the reception of the facility.

11. If the guests use the parking lot, payment for the use of the parking is made before the start of the stay or on arrival in cash, by payment card at the reception or by bank transfer, in advance for the entire period of stay.

12. The car park is subject to current road traffic regulations.

13. The parking lot has a maximum speed of 5km/h.

14. The vehicle user shall limit the engine stop/start time to the minimum necessary.

15. During parking, the vehicle operator is obliged to pay special attention to neighboring vehicles and set the vehicle in designated bays, without exceeding the lines determining the parking spaces. It is prohibited to:

- parking vehicles on marked fire and internal routes and in a way that prevents access to them,
- obstructing or blocking the traffic of vehicles in the parking area by parking vehicles on the maneuvering area,
- parking vehicles in green areas and in places where parking the vehicle may cause danger to people, property and traffic of vehicles.

16. The vehicle left in the car park should be properly secured by among others:

- engine shutdown,
- switching off the lights and other receiver of currents except for the car alarm,
- closing of windows and doors. The operator of the vehicle protects his vehicle against theft. It is forbidden to leave pets, children and other people requiring care in the vehicle when parked in the parking area.

17. The operator of the vehicle throughout the parking lot is obliged to comply with the following prohibitions:

- smoking and using open flames,
- alcohol consumption and use of drugs,
- repairing, washing, vacuuming the vehicle, changing coolants, fuel or oil, as well as polluting the parking lot,
- leaving vehicles with the engine running,
- parking vehicles with leaky systems causing leaks,
- driving without the dipped beam switched on,
- conduct contrary to the rules of social coexistence or disturbing order,
- to comply with and carry out orders of a order nature employees of INTERFERIE or other authorised people or relevant services.

18. The vehicle operator is fully responsible for any damage caused by INTERFERIE and

third parties in the parking lot. In the event of damage, the vehicle operator is obliged to immediately inform INTERFERIE about the resulting damage before leaving the car park.

19. In the case of a non-conforming with terms and regulations of parking the vehicle Or parking it in a way having direct impact on the safety of people or property, as well as in the absence of payment for the use of the parking lot, the vehicle operator agrees to rearing the vehicle by the appropriate security service. The vehicle's towing away will be performed at the expense and risk of the vehicle operator.

20. Children can stay in the car park only under care of an adult.

21. INTERFERIE may refuse acceptance to the parking and parking of the vehicle. In justified cases INTERFERIE may decide to temporarily disable the car park from use or change the hours of its availability, excluding any claims of operators in this respect.

22. Any remarks concerning irregularities in the functioning of the car park or activities contrary to the provisions of these Terms and regulations by vehicle operators or other people, should be reported directly to the reception staff.

23. These Terms and regulations apply from July 19, 2019.
