

SWIMMING POOL REGULATIONS OF THE BELWEDER HOTEL IN USTRON

- 1. The Swimming Pool zone (hereinafter also: Swimming Pool) is located in the Belweder Hotel in Ustroń at Zdrojowa 15 and is owned by Farmacol S.A. It includes a swimming pool, a changing room with showers, a Jacuzzi and water jets.
- 2. The Swimming Pool is open from Monday to Friday from 9:00 a.m. to 9:00 p.m. Any changes to the opening hours will be announced at the reception desk of the Belweder Hotel and shall be effective from the moment of announcement.
- 3. The use of the Swimming Pool is included in the price of accommodation for guests staying at the Belweder Hotel during their hotel night. The Swimming Pool is available to the visitors from outside subject to a fee:
 - > Entry up to 4 hours PLN 100,00 per adult or for a child over 12 years of age. For children up to 12 years of age the fee is PLN 50,00. Children up to 4 years of age entry is free
 - > Entry over 4 hours or full day PLN 150,00 per adult or for a child over 12 years of age. For children up to 12 years of age the fee is PLN 75,00. Children up to 4 years of age entry is free.

Any changes to the Swimming Pool price list will be announced at the reception of the Belweder Hotel and shall be effective from the moment of announcement.

- 4. Before entering the Swimming Pool and using the swimming pool equipment, it is necessary to read these regulations and instructions for use of the swimming pool attractions and to follow them during your stay in the swimming pool.
- 5. Persons violating the provisions of these regulations shall be removed from the facilities without the right to a refund of the previously paid fees. All persons present at the premises of the facility are obliged to immediately comply with the announcements made.
- 6. Children under 13 may be present at the swimming pool only under the care and supervision of adults, and children over the age of 13 and up to the age of majority can use the swimming pool with the consent of their guardians.
- 7. Persons intending to enter the swimming pool, regardless of whether they will be using the swimming pool equipment or the swimming pool basins, are obliged to change their shoes to clean rubber shoes such as flipflops, and to change their clothes to swimming suits, and, in case of the guests who do not stay at the Belweder Hotel, to leave their shoes and clothes in the changing room. Hotel slippers may not be used as footwear allowed for use in the swimming pool zone.
- 8. Before entering the swimming pool zone, all Guests are obliged to shower using washing products and to rinse their feet with a disinfectant in a designated paddling pool. After leaving the toilet, the Guests are obliged to shower and rinse their feet with a disinfectant in a designated paddling pool again.
- 9. The use the swimming pool is forbidden for persons:
 - who are under the influence of alcohol or drugs;
 - who are ill (suffer from skin diseases, respiratory tract infections etc.);
 - with medical contraindications;
 - with Band-Aids and bandages.
- 10. Persons staying at the Swimming Pool are forbidden to:
 - smoke cigarettes;
 - run in the swimming pool zone as well as in the corridors, the swimming pool hall and swimming pool pits, changing room and shower rooms;
 - consume food in the changing room and the swimming pool hall; drink alcoholic beverages;
 - use the lifeguard's rescue equipment for purposes other than those intended;
 - jump into the water;
 - chew gum;
 - bring animals in;
 - damage the swimming pool equipment and facilities;
 - pollute the swimming pool water;
 - use products, including cosmetics, in glass packaging;
 - initiate false alarms;
 - leave children under 13 years of age unaccompanied by an adult;
 - enter with and use large swimming equipment such as inflatable boats or mattresses.
- 11. Guests are obliged to use the designated stairs to enter and exit the swimming pool. It is forbidden to move between the swimming pool sections (namely, from the shallower part of the swimming pool to the deeper part of the swimming pool and vice versa) in any way other than by using the designated stairs.
- 12. Children under 3 years of age and older, if they require diapers, may only use the swimming pool in special swim diapers.
- 13. All persons present at the Swimming Pool are obliged to obey instructions of the personnel and, in particular, of the lifeguard on duty. The management of the Swimming Pool and the staff have the right to check sobriety of persons entering the facility or present at its premises. Refusal to undergo the sobriety test will result in expulsion from the swimming pool without a refund of the entrance fee. In case of danger, the lifeguard may order the swimmers to immediately get out of the water.
- 14. Persons in poor health, unfit or unwell, as well as pregnant women, should use the swimming pool and its facilities with special care, and in a way suitable to their health status. Farmacol S.A. shall not be liable for health consequences resulting from the use of the swimming pool by such persons.
- 15. Any wounds, injuries, perceived dangers and irregularities are to be reported to the lifeguard immediately, and if they cannot be reported to the lifeguard, they should be notified to other members of the Belweder Hotel staff.
- 16. Persons who cannot swim may only use the designated non-swimmer zones.
- 17. Only authorised persons may stay in the lifeguard's room. Unauthorised access is forbidden.
- 8. Farmacol S.A. shall not be responsible for personal belongings left in the swimming pool's changing room.
- 19. Persons who cause damage to the swimming pool equipment or facilities shall be liable for such damage in full amount. Parents or guardians are liable for damage caused by minors.
- 20. After leaving the swimming pool, resting for 20-30 minutes is recommended.
- 21. Farmacol S.A. is not responsible for any negative effects of using the swimming pool hall, in particular caused by a violation of the regulations, instructions for the use of water attractions and instructions of the personnel. Farmacol S.A. is not responsible for damage to swimwear in the swimming pool hall.
- 22. The Regulations may be changed at any time and the changes shall be effective from the date of the announcement at the reception desk of the Belweder Hotel or on the date indicated.
- 23. These Regulations shall come into effect on 28 May 2021.
