

SAUNA REGULATIONS OF THE BELWEDER HOTEL IN USTROŃ

- Saunas located in the Belweder Hotel in Ustroń at ul. Zdrojowa 15 are owned by Farmacol S.A. They include a dry sauna, a steam sauna and showers.
- 2. The Saunas are open from Monday to Friday from 8:00 a.m. to 9:00 p.m. with a technical break from 1:00 p.m. to 3:00 p.m.; on Saturdays from 8:00 a.m to 9:00 p.m. with no technical break; on Sundays from 8:00 a.m. to 8:00 p.m. with no technical break. Any changes to the opening hours will be announced at the reception desk of the Belweder Hotel and shall be effective from the date of the announcement.
- 3. The use of the Saunas is included in the price of accommodation for the guests staying at the Belweder Hotel during their hotel night. The Saunas are available to the visitors from outside subject to a fee of PLN 60.00 per person/per day for using the Saunas, payable at the reception desk of the Belweder Hotel before entering the Saunas. For persons under 12 years of age, the fee is PLN 30.00. The time of using the Saunas runs from the moment of purchasing the ticket at the reception desk of the Belweder Hotel to the moment of leaving the Saunas. Any changes to the Sauna price list will be announced at the reception desk of the Belweder Hotel and shall be effective from the moment of announcement.
- 4. Before entering the Sauna zone and using the Saunas, Guests are obliged to read these regulations and the instructions for use, and to follow them during their stay in the Sauna zone.
- 5. Persons violating the provisions of these regulations shall be removed from the facilities without the right to a refund of the previously paid fees. All persons present at the premises of the facility are obliged to immediately comply with the announcements made.
- 6. The saunas may be used by persons over the age of 18, while younger persons may only be present in the saunas accompanied by an adult auardian.
- 7. Persons over the age of 50 and children under the age of 6 may use the saunas after consulting a doctor. The presence of children under the age of 6 in saunas requires prior submission of a written declaration from parents that they accept full responsibility for any health problems connected with the presence of children in the Saunas and that they will not address to Farmacol S.A. any claims for children's potential health problems related to their stay in the Saunas. The declaration is available from the lifeguards.
- 8. The use of the Saunas is forbidden for:
 - persons who suffer from various cardiological diseases;
 - · persons with rheumatism, asthma and high temperature;
 - · persons with various inflammatory conditions of internal organs;
 - · persons who suffer from thyroiditis or epilepsy;
 - · pregnant women;
 - small children.
- 9. Each Sauna user is required to have his/her own clean towel. The guests must use saunas barefoot, with no swimsuit on, covered with a towel only.
- 10. Before each session in the Saunas, the users must remove all metal items.
- 11. Glasses and contact lenses are not allowed in Saunas.
- 12. Events of sudden deterioration in health or well-being must be reported to the lifeguard.
- 13. Each person stays in the Saunas on their own responsibility, and in the case of minors on the responsibility of parents or guardians.
- 14. Farmacol S.A. shall not be responsible for negative effects of using the Saunas .
- 15. Good behaviour principles shall apply in the Saunas.
- 16. Persons staying in the Saunas are forbidden to:
 - smoke cigarettes;
 - · run in the corridors, the saunas, changing room and shower rooms;
 - · consume food in the changing rooms and the swimming pool hall, and drink alcoholic beverages;
 - use the Sauna facilities and equipment for purposes other than those intended;
 - · bring animals in;
 - · damage Sauna equipment and facilities;
 - · move, touch hot stones and the furnace;
 - · sit and lie on boards of benches without a towel;
 - · damage Sauna facilities
 - · speak in raised voice.
- 17. Persons who cause damage to the Sauna equipment or facilities shall be liable for such damage in full amount. Parents or guardians are liable for damage caused by minors.
- 18. The Regulations may be changed at any time and the changes shall be effective from the date of the announcement at the reception desk of the Belweder Hotel or on the date indicated.
- 19. These Regulations shall come into effect on 28 May 2021.
