

RULES OF SWIMMING POOL, SAUNAS, JACUZZI AREAS IN CROCUS HOTEL ****

Dear guests!

For the safety and comfort of users of the swimming pool, sauna and jacuzzi areas, please take a few moments to familiarise yourself with and then obligatorily comply with these rules.

A. GENERAL PROVISIONS:

1. The swimming pool, saunas and jacuzzi areas may be used by individuals, including children under 14 years of age under the constant supervision of an adult person.
2. The following areas: swimming pool, saunas, jacuzzi may be temporarily excluded from use. In such cases, the area excluded from use will be marked by placing a demarcation tape. Use of the areas during this time is prohibited.

B. USERS OF THE SWIMMING POOL, SAUNAS AND JACUZZI AREAS ARE OBLIGED TO:

1. Enter the area only in the generally accepted swimming costume, swimming pool footwear which has grooves on the sole to increase the shoe's grip on the ground. It is prohibited to enter the areas barefoot.
2. Each person is required to wash his/her entire body in the shower using appropriate cosmetics before entering the areas. The use of cosmetics outside the shower areas is prohibited.
3. Children under 3 years of age using the pool must wear waterproof swim nappies.
4. All persons are obliged to obey lifeguards and their orders.
5. All cuts, injuries and irregularities must be reported immediately to the lifeguard on duty.
6. Within the areas, it is obligatory to maintain order, cleanliness, peace and quiet and to obey the decisions of the lifeguard or instructor.

C. THE FOLLOWING PERSONS WILL BE NOT ALLOWED IN THE SWIMMING POOL, SAUNAS, JACUZZI AREAS:

1. Whose condition indicates consumption of alcohol or other similarly acting agents.
2. With open wounds and skin inflammations.
3. With signs of diseases that pose a risk of drowning.
4. Whose behaviour poses a risk to users of the swimming pool.
5. Whose state of personal hygiene deviates from generally accepted standards.

D. IN THE SWIMMING POOL, SAUNA AND JACUZZI AREAS, including changing rooms and showers, IT IS FORBIDDEN TO:

Cause situations that threaten their own safety and that of the people in the area, in particular:

1. Carrying sharp objects (watches, bracelets, and other jewellery) in the water.
2. Bringing in inflatable mattresses and toys.
3. Running, jumping, pushing and throwing in the water.
4. Smoking cigarettes.
5. Consuming alcoholic beverages and all types of food.
6. Bringing in glass containers, cans, sharp tools and other dangerous easily breakable objects.

7. Noisy behaviour, shouting or raising false alarms.
 8. Using goggles other than swimming goggles.
 9. Destroying equipment and facilities that are part of the areas.
- E. USER RESPONSIBILITY IN THE SWIMMING POOL, SAUNAS, JACUZZI AREAS:
1. The locker must be left closed before leaving the changing room.
 2. The Hotel is not responsible for items left in open or improperly closed lockers or in unattended areas.
 3. The Hotel is not liable for any damage caused by non-compliance with the rules and regulations.
 4. A charge of 100% of the value will apply for damaged or lost area equipment.
 5. Parents or their guardians are responsible for any damage caused by minors.
- F. FINAL PROVISIONS:
1. The use of the swimming pool, sauna or jacuzzi areas is tantamount to acceptance of the above regulations.
 2. Matters not covered by these rules shall be settled by the General Regulations and the Hotel.
